



Membership Charter

1 Name

The Queensland Symphony Orchestra Friends group will be known as the “QSO Friends”.

2 Purpose

The QSO Friends is for people who wish to deepen their orchestral experience through interaction with orchestra players and other like minded music lovers. QSO Friends advocate support for the Orchestra’s through personal contacts and relationships within the community.

3 Membership

Benefits are accorded to members in exchange for payment of an annual membership fee. Non-refundable annual membership is for a 12 month period January to December. Gift memberships may be purchased. Membership is open to the general public and is not limited to subscribers.

4 Management

The management and administration of the QSO Friends will be the responsibility of the QSO. Events and materials associated with these events will be produced by QSO management. QSO management will be responsible for the management of member records and information.

5 Vice Regal Patronage

The Governor of Queensland is the Patron of the QSO Friends and will support the QSO Friends activities.

6 Use of Information – Privacy

The QSO Privacy statement outlines our information gathering and dissemination practices based on the Australian Privacy Commissioner’s National Principles for the Fair Handling of Personal Information. Specifically, no member data collected will be disclosed to a third party except where it is legally required or otherwise authorised. From time to time we will mail members information we think is of interest, however members always have the option of requesting to be removed from mailing lists.
